As such applications from intending candidates from Kamrup(M) district are invited from the following groups of people:

Teachers (includes retired teachers), retired Govt. Servants and Senior Citizens, M.S.W. students, Anganwadi Workers, Doctors / physicians, Law students (till they enroll as Advocates), Members of Non- Political, Service oriented NGOs and Clubs, Members of Women Neighborhood Groups, Maihtri Sanghams , Other Self-help Groups and any other persons with a bent of social work.

The Candidates should have minimum Matriculate qualification and capacity for overall comprehension, who do not look up to the income they derive from their services as PLVs and who have a mindset to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of the marginalized and weaker sections of the society.

It is to be mentioned that the work of PLVS does not carry any salary, remuneration or wages except honorarium fixed by the Assam State Legal services Authority from time to time.
