HC.VIII-76/2019/2939/AC dated 07.05.2021 of the Hon'ble Gauhati High Court, sealed tenders affixing Court Fee of Rs. 8.25 (Non-refundable) are hereby invited from reputed and registered Parties/Agencies/Firms/Individuals for outsourcing of 1 (one) vehicle on monthly rental basis for use as official vehicle of the Special Judge, CBI, Assam, Additional Court No. 1, Chandmari, Guwahati-3. Interested parties/agencies/firms/individuals who are willing to comply with the terms and conditions annexed to this notice may submit their tender.

The tender must reach the office of the undersigned **on or before 01:00 PM of 04.10.2021 and the tenders shall be opened on the same day, i.e. 04.10.2021 at 02:00 PM in presence of the tenderers or their representatives.**

TERMS AND CONDITIONS:

1. The cost price of the vehicle should not exceed Rs. 15 Lakhs.
2. The vehicle to be outsourced should be registered as a commercial vehicle.

3. The vehicle should not be preferably more than 1 year old and the total running should be preferably less than 20,000 Kms.
4. All maintenance of the vehicle shall be done by the outsourcing parties/agencies/firms/individuals **(except driver & fuel)**.
5. **No driver is required from the end of the tenderer.**
6. The contract period will be initially for 1 (one) year which may be extended (if necessary) or till new vehicle is provided by the Government.
7. The vehicle should be made available 24X7 in the service of the undersigned.
8. The vehicle should be comprehensively insured and should carry all necessary permits, clearance from the Transport authority or any other concerned authority, pollution certificate, fitness certificate etc. from the competent authority. Undertaking in this regard is required to be submitted by the tenderer along with the tender.
9. The interested parties/agencies/firms/individuals must submit the sealed quotation containing tender along with self attested copies of their GST Registration Certificate, PAN Card, Vehicle Registration Card, Vehicle Insurance Certificate along with other documents as mentioned in the notice.
10. The sealed envelope containing quotation shall be marked as "Quotation for Outsourcing Vehicle for Special Judge, CBI, Assam, Additional Court No.1, Chandmari, Guwahati-3".
11. The undersigned reserves the right to accept or reject any or all the tenders in part or full, without assigning any reason whatsoever.
